

INSTRUCTIONS FOR FILLING THE FORM FOR CDMA LIMITED MOBILE SERVICE

1. The form may be filled up in Capital letters only.
2. In the absence of PAN/GIR number, declaration in form 60 / 61 may be furnished in the enclosed proforma.
3. Please enclose address proof, any one attested copy of ration card, passport, driving license, election identity card, latest paid copy of BSNL Telephone bill along with receipt or any other documentary evidence in support of address.
- 4(a) If customer requires more than one telephone connection in the same name, Category and for installation at the same place, he/she may indicate here the number of telephone connection required.
- 4(b) For business CST/KST/BMP Certificate has to be submitted. In case of sole proprietary concern, proprietor may sign himself and affix rubber stamp.
5. In case of partnership concern, all partners or any one of the partners duly authorised or person with the Power of Attorney may sign. In case of Company, signature should be of a person on behalf of a Company, in accordance with the provisions of its Articles of Association. In case of partnership concerns, copy of (i) Power of attorney for authorization & (ii) Partnership Deed and in case of Limited Company, a copy of Articles of Association, may be attached.
6. In case of Government Departments, authorised person may sign and affix rubber stamp.
7. Demand Draft for payment to BSNL should be drawn in favour of 'BSNL, Bangalore T.D.'
8. If, at any stage, information furnished is found false - Telecom Service / Telephone provided is liable to be disconnected immediately without any notice.

10. # Handset Options

- Option I : Customer is free to have any CDMA handset (SPEC IS 95A)
- Option II : Own BSNL Handset by paying in 25 easy equal monthly instalments of Rs.200/- each
- Option III : Avail BSNL Handset with an insurance charge of Rs.20/- per month
(with an undertaking for minimum usage of 1 year)
- Option IV : Use BSNL Handset by paying Rs.5,000/- towards refundable deposit (on surrender in working condition)

NOTE :

- * Only in those cases where the connection is not available across the counter and the customer has to be kept in the waiting list.
- ** The Security deposit amount of Rs.2400/- of WLL (M) connection, may be exempted, subject to following conditions.
 - > Subscriber has a wired line PSTN connection (from BSNL) and had paid prescribed security Deposit on the existing wired line PSTN connection.
 - > WLL(M) Connection is without ISD.
 - > A mandate form is to be given by the subscriber to charge Security Deposit against landline towards WLL (M) connection.
 - > Subscriber remains liable to higher Security Deposit in case of default or usage pattern as in case of PSTN phones.
- *** The replacement of battery and consumable, if any shall be done by the customers themselves.
 - > In case of customer owned handsets, the customer shall ensure that CDMA hand held set meets IS-95A standard
